		The Chairman presented samples of two types of ID cards: General Members with a green strip and Senior Citizens/Vulnerable Members with a red strip. Red strip ID cards include detailed information such as date of birth and full address, facilitating identification by other service providers such as the NHS and Social & Welfare services for beneficiary recognition. This is performed according to the Data Protection Act and policies, which FNC adheres to and has its own policies in place (Assistant Treasurer Abesh Rai, Data protection Officer).	
		• As per last quarterly meeting on 01 September 2024, General Secretary reported that the FNC has procured a printer to produce the FNC Membership ID Cards at the FNC Centre, funded through the restricted office running cost grant.	
	b.	Card Payment:	
		The Chairman proposed the option of card payment for FNC members, including renewal of membership and purchasing tickets, raffle tickets at FNC's social events. After conducting research and discussing with Advisor Kishor Sapkota, it was determined that SUMUP card payment was the most suitable option for FNC, endorsed by FNC members who are self-employed taxi entrepreneurs. Therefore, the Chairman and the meeting assigned the Treasurer and General Secretary to make necessary arrangements to acquire SUMUP card payment. Thank you for attending the FNC 3rd Quarterly meeting today (Sun 08 Dec 2024) at FNC Centre. It was a highly productive session, and your collective insights have helped shape significant decisions for the advancement of FNC. Below are the advance notification of key updates and upcoming dates for your info and action as necessary:

- a. Launch of FNC Membership Card The meeting approved the launch of the FNC Membership Card. Active members who have paid the annual membership fee of £25 are requested to book an appointment with the General Secretary for the issuance of their membership card. The Vice-Chairman will organize a door-to-door campaign to boost membership numbers. Please read this paragraph along with the FNC Membership Annual Subscription Update letter issued on 05 Dec 2024.
- **b.** Implementation of Card Payment Facility As agreed at the meeting, a seamless payment system will be introduced to enhance revenue collection. This system allows us to align with modern practices, and our members and donors can make payments to FNC in three different ways: by card, online payment, and by cash.
- **c. FNC Senior Citizen Christmas Lunch** As previously informed, this will take place on 17 Dec 2024 at the FNC Centre. Attendance will be on a pay-as-you-dine basis. All are welcome. Please contact the FNC General Secretary or Senior Citizen Coordinators if you wish to attend ASAP.
- **d. FNC Charity Gala/Dinner** The meeting proposed holding an FNC Charity Gala/Dinner night, tentatively on 15 Feb 2025 (to be confirmed), possibly at the Grand Buston Hotel. Further confirmation will follow from the FNC Vice Chairmen soon.
- **e. Transfer of £150 from GPF** The meeting decided to discontinue this financial assistance, effective immediately, as FNC has recently secured funding from alternative sources. The committee will email the GPF Chairman to facilitate this.
- **f. FNC Annual General Meeting (AGM)** This will be held on Sun 30 Mar 2025 at the FNC Centre. All members are requested to free up their diaries to attend this annual meeting.
- **g. FNC Nepali New Year Celebration** As previously notified, FNC will hold this celebration on Sat 12 Apr 2025 (as previously announced), coordinated by Vice Chairman 1. Members are requested to free up their diaries to attend this celebration.

Further details of the meeting will be promulgated in the meeting minutes and circulated by the Gen Sec soon. In the meantime, we request our members to mark these dates and plan to participate actively.

#### **Purpose**

A meeting was held on 07 November 2024 at FNC Centre to clarify key issues of collaboration between Folkestone Nepalese Community (FNC) and ShivaNova/Equator Festival, ensuring the orderly functioning of the projects. The meeting discussed on collaboration of the following projects:

Pent Farm Community Garden
The World in the Tent Multicultural Festival
Nepalese Holi Celebration
Other/Heritage Projects

The meeting attended by the following:

Ms Priti Paintal (Director, Shiva Nova/Equator Festival)
Mr Jhapindra Thapa (FNC Trustee/FNC Rep for Pent Farm Community Garden)
Mr Chandra Shai (FNC Executive Committee/FNC Rep for Pent Farm Community Garden)
Dr Maha Rai, PhD (FNC General Secretary/Centre Manager)

These minutes will act as a reference and working document to guide actions and decisions regarding the above collaborative projects.

#### Agenda Item 1 - Pent Farm Community Garden

Follow-up from the 12 September 2024 Meeting:

#### a. Notes:

 Meeting notes from 16th September 2024, prepared by the FNC Chairman, will guide the roles and responsibilities of Pent Farm, ShivaNova/Equator, and FNC.

#### b. Workshop Reimbursements:

- ShivaNova/Equator will reimburse £1,000 for five school workshops conducted on 7th, 8th, 11th, 14th, and 15th October (£200/workshop).
- FNC will send individual invoices for each workshop to Ms. Priti Paintal (Director, ShivaNova/Equator Festival) for BACS payment to the FNC account, as per previous arrangements.

#### c. School Workshops Management:

ShivaNova/Equator will manage school workshops and their associated payments.

- FNC will support workshops upon request, subject to resource availability, with prior notice to the FNC Chair or General Secretary.
- ShivaNova/Equator will pay FNC for the use of staff, services, and resources (details to be shared in advance to allow FNC to invoice).
- Directly compensate individuals for overtime work, with prior notice of rates shared with FNC.
- Ensure that FNC raises invoices only for FNC services/resources and not for direct individual payments.
- All FNC staff involved in the project must have a DBS check. Coordination of DBS checks will be handled jointly by FNC and ShivaNova/Equator.

#### d. Future Projects:

• FNC staff will continue to provide ad-hoc support for future initiatives under terms set in paragraph 1c, given prior notice.

#### e. Ownership of Property at Pent Farm Community Garden:

- Assets like sheds, water tanks, and tools will remain under FNC's priority.
- In the event of project discontinuation, all parties will collaboratively decide on asset disposition.

#### f. Natural Calamities:

Pent Farm Manager, Tom, will oversee the relocation of sheds if required.

### g. Lease Agreement for Pent Farm Community Garden:

- FNC, Pent Farm, and Shiva Nova/Equator will finalise a lease agreement for the plot.
- In the mean times FNC is allowed to continue to use the land for the community garden project with an annual rent of £1200, which must be paid to the Land Manager to retain access and usage rights. (Note: This arrangement was acknowledged and reaffirmed during the meeting held on 12 September 2024 ensuring the project remains sustainable under these terms)

#### Agenda Item 2 - The World in the Tent Multicultural Festival

Annual Event Scheduled in July at the FNC Centre

#### a. Core Funding:

ShivaNova/Equator will secure core funding for the event.

#### b. Administrative Responsibilities:

 Shiva Nova/Equator will handle paperwork, including road closure permissions, in collaboration with Folkestone & Hythe District Council.

#### c. FNC Centre Facility and Support:

- FNC will provide volunteers and FNC Centre facilities as needed.
- ShivaNova/Equator will pay FNC a minimum of £600 for venue hire, Nepalese cultural shows, and volunteer food subsidies, upon invoicing.

#### d. Vendors and Performers:

- ShivaNova/Equator will organize multicultural performers and coordinate vendors for food, drink, and arts/crafts.
- FNC will manage its own food and arts/crafts vendor stall.

#### Agenda Item 3 - Nepalese Holi Celebration

Annual Event Scheduled in March at the FNC Centre.

#### a. Core Funding:

• ShivaNova/Equator will provide funding for colors, venue hire, cleaning, Portaloo (if needed), and administrative costs (Temporary Event Notice).

#### b. Administrative Responsibilities:

- Shiva Nova/Equator will handle paperwork, including road closure permissions, in collaboration with Folkestone & Hythe District Council
- FNC will supply volunteers and manage food and drink arrangements, alongside cultural activities.

#### c. Venue Hire and Cleaning:

- ShivaNova/Equator will pay FNC a minimum of £350 for venue hire and cleaning.
- FNC will provide Centre facilities for the event and arrange cleaning after the event.

#### Agenda Item 4 - Other/Heritage Projects

• FNC and ShivaNova/Equator will collaborate on additional projects under mutually agreed terms, provided FNC resources are available.

#### **Agenda Item 5. Conclusion**

- These minutes outline the framework for collaboration between FNC, Shiva Nova/Equator Festival, and Pent Farm Community Garden Project. Future updates will be documented to ensure transparency and coordination.
